# Student/Parent Expectations

## **Special Guidelines & Precautions For 2020:**

- *As per the current guidelines, all persons entering the studio to remain six feet apart from one another for safe physical distancing - face covering not required at all times in the studio until further notice*
- *Thorough hand washing required*
- *All dancers and parents agree they are healthy and have been around healthy people*
- *The lobby will remain locked and only dancers will be admitted into the studio (accommodation will be made for our pre-ballet & tutu students)*
- *DO NOT ATTEND if you have any sign of sickness/fever or if anyone in your household or anyone you have come in contact with in the last 14 days has shown signs of sickness or fever*
- *Student temperatures may be monitored with a digital thermometer*
- *All dancers please arrive 5 to 10 minutes prior to the start of class dressed and ready to dance*
- *We will be using separate outside entry doors for each studio to avoid crowding*
- *Latecomers will not be admitted*
- *Bathrooms and dressing room areas will not be available for changing*
- *Bathrooms will be available one person at a time as required (little ones will be supervised)*
- *Please do not arrive late to pick up your dancer*
- *Bring items for Conditioning class from home*
- *All barres and common areas are sanitized*
- *We have plenty of hand sanitizer & will continue on a deep cleaning schedule*
- *I understand my dancer may be seen on Zoom calls and recordings, as classes in the studio will also be on-line and classes on-line may also be in the studio*

## **Be Responsible, Respectful, Kind & Courteous**

- *IAD is only responsible for dancers that are in class. Please wait with children until the start of class.*
- *Pick up dancers promptly at the end of class.*
- *Arrive quietly.*
- *Speak softly and respectfully.*
- *Respect instructors, fellow dancers and staff members.*
- ***Be courteous of staff and limit discussion to IAD matters only.***
- *Make an appointment in advance or contact us if you have concerns or questions that require attention, as around class time is a difficult time for staff to focus on other matters.*
- *Please remove all shoes other than dance shoes before stepping on any of the dance floors.*
- *Please pack your trash. Garbage cans are provided in the bathrooms only to keep ants out of the studio.*
- *Place belongings in a cubby neatly and care for the property in and around IAD.*
- *If injured, IAD encourages dancers to observe class, take notes and participate as much as possible. There is much to be learned from listening, observing and participating as possible.*
- *Notify instructors immediately if injured or dealing with certain physical limitations.*

## **Be Prepared**

- *Come prepared to dance class with a positive attitude and dance attire.*
- *Dancers arrive early to warm-up, use the restroom and enter the studio ready to dance.*
- *Adhere to all dress code/uniform requirements with hair neatly pulled back for all dance classes, without dangly jewelry or distracting t-shirts, sweatshirts or other extra clothing items not included in uniform*
